Terms and Conditions

These terms and conditions govern your use of the eveash.com and Seven Dimensions' websites (known as EA & 7D).

By visiting or using our services, you agree to be bound by these terms and conditions.
 These terms and conditions constitute a contract between each user and the proprietor of EA & 7D's services. EA & 7D use the streaming service of ArcLearn™.

We reserve the right in our sole and absolute discretion to make changes from time to time and without notice in how we operate EA & 7D's services. Any description of how our service works should not be considered a representation or obligation with respect to how the service will always work. We are constantly making adjustments to our service and often these adjustments are not completely captured within these terms and conditions.

If you do not agree with these terms and conditions, you should not use our services.

2. Purchase DVD products

- When a product is purchased and payment is made the order is final and will be
 processed same day or the next working day, and cannot be cancelled. The price is
 as specified on the website and includes 10% (for gst in Australia or for overseas
 handling) plus there is a freight and handling fee. You will be notified a confirmation
 by email of when the parcel will be sent and the expected arrival time.
- Purchase of DVDs does not entitle the user to edit, alter or re-use the program footage, or put the program on the internet, intranet or any other kind of narrowcast or broadcast distribution. This requires purchase of a special electronic license only available from the producer (send request to info@7dimesions.com.au or their licensed representatives.
- Unless otherwise listed the programs purchased will all be in the English language. Contact us for requests in other languages.

2.1 DVD freight, Delivery and Restrictions

- When you order from Seven Dimensions we will send your parcel to virtually any
 address in the world, or we will enable one of our distributors to fulfill the order in
 some countries.
- We require a delivery address, and if overseas the address should be a street address. Every effort will be made to deliver the products within 2-3 business days of payment, depending on delivery address and products being in stock. Within

- Australia delivery may be within 24- 48 hours if to a major city, and will arrive by Australia Post to a PO Box address.
- If any delay is expected you will be notified. We request that if the products are not
 received within the expected timeframe that you will notify us so we can trace the
 parcel and ensure it gets to you or a replacement will be sent. If additional costs are
 incurred for a special delivery eg customs and duty for overseas, same day delivery
 in Australia, split delivery etc, then we reserve the right to send a further invoice for
 the additional charges.
- Any costs incurred by you through damage to a DVD or DVD player or other equipment or software or storage facility will be your own liability.

2.2 Refund and Replacement Policy

- If any products are found to be faulty or an error was made in the shipment, and the products are returned within 30 days they will be replaced. We will pay the return shipping costs if the return is a result of our error (you received an incorrect or faulty item). If a product is found to be unsuitable, and we are advised and the product is returned in good order, an exchange will be made for an alternative product and in some cases where this is not possible a full refund less shipping will be made.
- After 30 days a damaged title will be replaced at 25% of current retail price within first year, 50% in 2nd year and 75% in the 3rd year, then full price, plus freight charges and an admin charge of AUD \$33. The damaged item must be returned prior to replacement.

3. Grant of License

- All license purchases from EA & 7D impart certain rights to you regarding what products or services are available for use. The license is not to be construed as a transfer of ownership. In all cases, ownership of all program titles will remain with the legal rights holder of the program title.
- All program titles are offered on a licensed basis through the purchase of an Access
 License or Subscription Service License for a specific program title or group of titles.
 The license gives you usage rights to view the course content for a specific term
 and/or a maximum number of plays, within the primary service area (see
 Geographic Limitations). Once the license expires or when otherwise terminated,
 you have no further rights with respect to the licensed materials.

3.1 Access Licenses

- Access Licenses are sold for a maximum number of plays within a specific license term. Once the maximum number of plays is exhausted, the license is terminated.
 Once the license term is completed, the license is terminated.
- What is a "play"? Beginning a program on a computer opens a three-hour viewing period which counts as one play.
- Each license starts with a one year term. Purchasing additional plays extends the term for another year and any unused plays are extended as well. Otherwise, after one year, the term is ended and unused plays are lost. The license is terminated when all purchased plays are exhausted.
- Any single purchase of at least 350 plays extends the term to three years.
- Some Access Licenses have specific limitations, such as the Local Play Only license.

3.2 Subscription Service Licenses

- Subscription Service Licenses provide unlimited use of the entire library of courses for a monthly fee per employee or person. Since this license type is meant to provide self-study learning, this license only provides course viewing using the Your Courses list for eLearning and mLearning.
- Each employee or person using the service must be registered; no sharing of login credentials is allowed. Such sharing is in violation of these terms and conditions.
- The subscription allows one to purchase one or more Employee Licenses where the number of employee licenses is the maximum number of employees or persons allowed to use the service. Additional employee licenses can be purchased at any time.
- The subscription allows for the removing and replacing of one employee with another. However, if any employee uses the service, that employee cannot be removed for a period of one week after the last usage. Thereafter, removal and optional replacement is allowed.
